## Chilled Semen Conditions.

- The mare Owner will pay to D.B. & J.M. Redgen a **BOOKING FEE** of \$330.00 for *each mare* inseminated (Deductible from the Service Fee but non-refundable if the mare fails to go in foal).  
**Direct Deposit details – DB & JM Redgen, BSB – 817 001, Acc# - 400303112.**
- The mare owner will also be charged a **TRAVEL FEE** of \$\_\_\_\_\_ each time the Stallion owner is required to travel to a **NON-LOCAL** Equine Veterinary Centre for collection of the stallion. This fee is not deductible from the Service fee and is also non-refundable. *(Usually, collection occurs locally, and this fee does not apply)*
- The mare owner is also responsible for the semen **COLLECTION FEE** charged by the Equine Veterinary Centre, and semen courier and transport costs. The mare owner (or their vet) is responsible for contacting the vet centre to arrange semen collection.

- The balance of the **SERVICE FEE** of \$\_\_\_\_\_ is required to be paid upon a positive pregnancy test. This pregnancy test is to be by the mare owner's nominated vet. Please provide details of vet to be used.

- All ancillary costs, Semen Collection Fees, mare pregnancy test and any expenses incurred by the mare owner are the responsibility of the mare owner.
- If the mare owner **INSEMINATES MULTIPLE MARES** in the 2021 breeding season, the first mare with a positive pregnancy test will have a **total service fee** of \$1210.00 The second mare with a positive pregnancy test will have a service fee of \$1100.00 Additional mares \$990.00. A separate contract is required for each mare.
- The mare owner will pay for all **VETERINARY EXPENSES** incurred for the mare. The mare owner warrants that, to their knowledge, the mare is in good health.
- A **LIVE FOAL GUARANTEE** is given for two {2} years (*conditional upon the total service fee being paid*), and thus if the foal is born dead or the mare loses the foal during pregnancy, the mare owner is entitled to return a mare to the stallion, either live coverage or AI, for the following year and will incur no service fee. All ancillary costs, collection fees and/or expenses associated with the return service will be at the mare owner's expense.
- Should the stud owner be unable to or **FAIL TO PERFORM** this contract by reason of death, injury or sale of the stallion prior to servicing the mare, the Booking fee and Balance of the Service Fees paid by the mare owner will be refunded. Mare owners wishing to utilise a Return Service granted under the Live Foal Guarantee, will be refunded the Balance of the Service Fee but will forfeit the Booking Fee. In both circumstances the refund will not include any of the ancillary costs, fees and or expenses associated with the attempt to perform this contract. Thereupon neither party shall have any right against the other.
- This contract shall not be **ASSIGNED OR TRANSFERRED** by the mare owner without the written consent of the stud owner.
