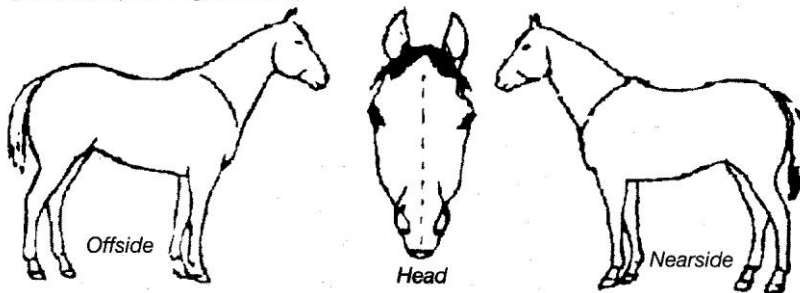

These Parties hereto contract for the servicing of the above mare by the above stallion for the 20\_\_\_\_\_ breeding season, **subject to the following conditions:**

- The mare Owner will pay a **BOOKING FEE** of \$275.00 to D.B. & J.M. Redgen. (Deductible, non-refundable). The balance of the **SERVICE FEE** of \$\_\_\_\_\_being paid, together with any ancillary costs, fees and/or expenses incurred in the performance of this contract, on a positive pregnancy test, or prior to the mare leaving the stud. All such ancillary costs fees and/or expenses will be recorded and documentation will be provided with the final receipt of payment of the balance of the Service Fee. "Walk on" mares will be accepted with prior arrangement and full payment of service fee. **Total Fee = \$\_\_\_\_\_.**

- **AGISTMENT** will be charged from the date of arrival of the mare at the "Braeview Stock Horse Stud" until the day of departure inclusive, at the rate of \$\_\_\_\_\_per day dry mares and \$\_\_\_\_\_ per day wet mares, including GST. Any specialised care arrangements are to be made with the stud owners prior to the mares' arrival. Reductions will be made if mare owner provides feed. (Rates subject to change due to seasonal conditions.)
- The mare owner will pay for all **VETERINARY EXPENSES** incurred for the mare. The mare owner warrants that, to their knowledge, the mare is in good health and has not been in contact any infectious equine diseases. The stud may at any time and at the expense of the mare owner, have the mare examined by a veterinarian nominated by the stud owner for whatsoever purposes and may treat or reject the mare at their discretion. Mares seventeen {17} years and older will require on stud fertility examination. If the stud owner thereupon rejects the mare, the mare owner will immediately remove the mare and pay all costs, fees and/or expenses out standing.
- Upon delivery, the mare will be **WORMED** at the mare owner's expense with a Moxidectin, Abamectin or Ivermectin based wormer. The mare owner can provide the wormer, but worming must occur on the stud.
- A **LIVE FOAL GUARANTEE** is given for two {2} years and thus if the foal is born dead or the mare loses the foal, the mare owner is entitled to return a mare to the stallion for the following year and will incur no service fee. All ancillary costs, fees and/or expenses associated with the return service will be at the mare owner's expense, including replacement of registration paperwork.
- All **TRANSPORT** arrangements and costs shall be the responsibility of the mare owner. The mare owner must give the stud owner at least forty-eight {48} hours notice of intentions to deliver or collect the mare.
- **WINDSUCKERS** will only be accepted with prior notice, and for a "walk on" service. Any mare deemed to be a windsucker by the stud owner after delivery will require removal from the stud within 24 hours. No live foal guarantee will be granted to windsuckers.
- The stud owner accepts no **LIABILITY** for the mare and/or its progeny while she is in the custody of the stud owner. The stud owner warrants that all necessary precautions will be taken to ensure the well being of the mare and/or its progeny while on the stud property.
- Should the stud owner be unable to or **FAIL TO PERFORM** this contract by reason of death, injury or sale of the stallion, the Booking Fee and the balance of the Service Fees paid by the mare owner will be refunded. Mare owners wishing to utilise a Return Service granted under the Live Foal Guarantee, will be refunded the Balance of the Service Fee but will forfeit the Booking Fee. In both circumstances the refund will not include any of the ancillary costs, fees and or expenses associated with the attempt to perform this contract. Thereupon neither party shall have any right against the other.
- This contract shall not be **ASSIGNED OR TRANSFERRED** by the mare owner without the written consent of the stud owner.
- If the mare and/or its progeny is left at "Braeview Stock Horse Stud" for a period of five (5) consecutive months with no agistment or similar expenses having been paid by the mare owner, the horse or horses will be deemed to have been **ABANDONED**. The stud owners reserve the right to sell or dispose of all abandoned horses left at "Braeview Stock Horse Stud" and to recover their expenses from the proceeds.
